

Learning how research is conducted and reported

Defining research

- How do you define research? Write down your definition.
 - The act of developing new knowledge.
 - A process of steps used to collect and analyze information in order to increase our knowledge about a topic or issue.
 - 1. posing a question
 - 2. collecting data about the question
 - 3. analyzing data to answer the question



Not all scholarly writing reports research! Scholarly writing also includes...

- Literature reviews
- Theoretical discussions
- Opinion papers
- Program descriptions
- Fiction
- Poetry
- And more!



Identifying research

- How can you recognize a research report?
 - The report is identified as research with terms such as study, inquiry, investigation, and research;
 - The report describes the collection of data;
 - The report describes the analysis of data.


Hold on—what about philosophical research?

- Good question! Our text has a pretty narrow perception of what constitutes research.
- This text is only acknowledging empirical research—research that involves the collection and analysis of data. Please be aware of this bias!






- In pairs, find a piece of scholarly writing that addresses an education topic that is NOT a research article.

Types of documents where research reports are found


- Early stage materials
 - Conference papers, newsletters, dissertations and theses, papers posted online
- Journal articles
 - Peer reviewed and editor reviewed
- Books
 - Encyclopedias, handbooks, research reports, collections of studies

Steps in the research process

- 1. identifying a research problem
- 2. reviewing the literature
- 3. specifying a purpose
- 4. choosing a research design
- 5. selecting participants and collecting data
- 6. analyzing the data and reporting results
- 7. drawing conclusions
- 8. disseminating and evaluating the research
